### INTERNATIONAL TOWING TANK CONFERENCE

- \* The ITTC is a Voluntary Association of Worldwide Organizations that have Responsibility for the Prediction of the Hydrodynamic Performance of Ships and Marine Installations <u>Based on the Results of Physical and</u> <u>Numerical Modeling.</u>
- \* It is **not** a Conference for Presentation of Scientific Papers.

### Origin of the ITTC

- Originator of ITTC was Edmund Telfer a Naval Architect in London.
- \* Telfer persuaded his ship owner friend, John (Giovanni) de Meo, to bring the leading Tank Superintendents together for "Terminology" & "Test" Standardization.
- John de Meo made a strong plea for International Technical Co-operation in the Field of Ship Performance Prediction from Model Tests at the "International Hydro-Mechanical Congress" in Hamburg in 1932.

## International Conference of Tank Superintendents

The Beginning

1933 – L. Troost of Wageningen Tank invited Tank Superintendents for First Meeting in the Hague.

- First Step in Reaching Agreement on Standard System of Publication of Tank Results.

- 22 Delegates from 15 Organizations Attended

## International Conference of Tank Superintendents

- \* Other Meetings Held in 1935, 1937, 1948, 1951 and 1954.
- \* 1948 First Technical Committees Established -Cavitation, Propeller & Skin Friction. Standing Committee Established (Later, Controlling Body then Executive Committee).
- \* 1951 3-Year Period between Meetings Established
- \* 1954 Name Changed to the ITTC

1963 - 10<sup>th</sup> Conference – Teddington

- \* English Made Official Language.
- \* Membership Open to All Towing Tanks with Direct Responsibility to Ship Builders, etc.
- \* Controlling Body Formed from the Superintendents of Each Member Organization.

\* 1969 - 12<sup>th</sup> Conference - Rome

- \* Controversy over Seating of Delegates.
- \* List of Member Organizations Cancelled.
- \* Concern of Larger Towing Tanks Over Technical Committee Recommendations.
- \* Need Redefinition of Membership.

1972 - 13th Conference – Berlin/Hamburg

- \* Organization Redefined. Controlling Body Authority Abolished.
- \* Advisory Council Formed of Larger Tanks.
- Executive Committee Formed of Chairs of the Geographical Areas (America, East Asia, Eastern Europe, Northern Europe, Southern Europe, Scandinavia and United Kingdom).

- \* <u>1990 19<sup>th</sup> Conference</u>. Korea and China Concern over Lack of Membership on Technical Committees.
- \* <u>1993 20<sup>th</sup> Conference</u>, Need to Revise Rules:

1. Change in Technology (Emergence of Numerical Modeling) .

- 2. Emergence of ISO and Quality Standards.
- 3. Change in Member Organizations and

4. Change in World Situation. New Geographical Areas Defined: America, Central Europe, East Asia, Northern Europe, Pacific Islands, Southern Europe.

- \* <u>1996 21<sup>nd</sup> Conference, Bergen/Trondheim</u>
- New Committee Structure.
- \* <u>2002 23<sup>th</sup> Conference, Venice</u>
- \* Publication of First Recommended Procedures.
- \* <u>2005 24<sup>th</sup> Conference, Edinburgh</u>
- \* Establishment of Membership Fees & ITTC
  Secretary, Systematic Registration of Membership.
- \* <u>2008 25<sup>th</sup> Conference, Fukuoka</u>
- \* Rules Updated and Revised for Consistency.

#### **International Towing Tank Conference**

- The Number of Attendees Have Grown from 22
  Delegates from 15 Organizations in 1933 to over 130
  Delegates from 70 Organizations with a Total of over 200 Attendees.
- \* The Concern of Telfer & de Meo on "Terminology" & "Test" Standardization has been Achieved.
- \* 27<sup>th</sup> Now in Copenhagen.
